### Res Ipsa Loquitur (RIL) Advertising Order Form

### **Deadlines**

All advertising copy and payments must be made no later than by the  $\underline{\mathbf{3}^{rd}}$  of the month to be included in the next month's issue. An additional charge of \$50 will be assessed for any changes submitted on or after the  $10^{th}$  of the month. An additional charge of \$100 will be assessed for any changes submitted on or after the  $12^{th}$  of the month; if space is still available. No changes will be accepted after 5:00 p.m. on the  $14^{th}$  of the month.

### **Cancellations**

Any desired cancellations must be received in writing prior to the space reservation deadline. If fewer insertions are run than originally contracted, advertiser agrees to pay the difference between the rates paid and the actual rates earned (short rate) within 10 days of billing. All advertisements are accepted upon the representation that the agency or agent submitting the ad is authorized to publish the entire contents thereof. The agency (if any) accepts the responsibility for payment as advertiser's representative. The RIL and its agents shall not be liable for any cost of damages if, for any reason, an advertisement fails to be published. The advertiser will be billed for advertising when cancellation occurs after reservation closing date; regardless of ad run for that issue.

### **Artwork**

All advertising must be submitted 'camera ready'; which is high-resolution quality ads only (preferably in color). The specifications for the types of Ads submitted are:

- 1) EPS file, CMYK, 300 DPI all text converted to outlines or paths, all art used must be included and saved as either CMYK, 300 DPI TIFF or EPS
- 2) TIFF file, CMYK, 300 DPI
- 3) PDF file, high resolution 300 DPI

**Note**: Quark, Publisher, PowerPoint, Microsoft Word files and/or Faxes <u>cannot</u> be accepted.

### **Ad Creation**

Our expert designer can help create your ads. Ad Creation includes design, layout, typesetting, with the use of client's logo and photography as supplied. If design work is needed, the client will be billed by the designer at \$125 an hour, with a \$50 minimum.

Price includes color email proof and one round of proofing changes. There will be an additional \$10 charge <u>per change</u> after initial proofing and an additional \$50 charge for changes <u>after final</u> approval.

### **Creative Usage**

Materials produced by the Kern County Bar Association may be used in other media at no additional charge. A \$15 charge will be required to provide the client's ad on CD. Resizing of ad for other media will be billed at \$65 per hour, one hour minimum.

### **Ad Placement**

The RIL at its sole discretion may accept, reject, or cancel any advertisement for any reason at any time. Furthermore, the RIL reserves the right to publish materials from a previous advertisement if new materials are not received by material deadline. If no materials are received by the specified due date, the contracted advertiser will be liable for the space rate. The positioning of submitted display advertisement is at the discretion of RIL; except when the approved advertiser has contracted and paid for preferred position and/or RIL promises a specific position in writing. Advertising materials may be returned to the advertising client if requested in writing; they would be returned post full payment and ad run. The RIL retains copyright on ads produced by the magazine, and electronic files remain the property of the magazine.
